### Note:

1. All permit applications are subject to review and approval by city staff.
2. Proof of residency is required prior to issuance of parking permit(s)
3. Allow 2-3 weeks for processing.
4. Permits are issued to homeowners only that reside on a street.
5. Permits are issued to residents that do not have adequate off-street parking spaces for vehicles registered to that property.
6. The licence plate of the vehicle must be provided and displayed on the front of the permit.
7. Applicants must demonstrate need for permit.
8. 1 permit per vehicle
9. All snow clearing parking permits are reviewed on an individual basis and are not granted solely for convenience or number of vehicles residing at a residence.
  - a. Applicant must demonstrate need for snow clearing parking permit (insufficient off-street parking for motor vehicles registered to that property).
  - b. Proof of residency and the motor vehicle registration must be shown before permit is issued.
10. Commercial loading zone permit allows the permit holder to park at on-street parking meters for a maximum of 30 minutes while actively loading and unloading goods.

★ Residential Parking Permits may be subject to residential survey.

The City of Welland has the right to revoke any permit at anytime as a result of misuse or duplication. Motorists must continue to obey all general by-laws (i.e. Proximity to intersections, driveways, fire hydrants, 12 hour limit, snow removal, etc.).
